On Monday, April 12, 2010 at 1:30 PM the Snoqualmie Nation will be holding its General Meeting to elect the Tribal Chairperson, Tribal Council and Council Alternates. This election will be a rerun of the May 9, 2009 election that was invalidated by the Snoqualmie Tribal Court in October 2009 (Case No. CV-0003-2009, Snoqualmie Tribal Court Order issued October 16, 2009). TrueBallot, Inc. will be acting as the election administrators for this election.

As a registered member of the Snoqualmie Nation, you are qualified to cast one ballot.

A list of candidates that have declared their intention to run for Chairperson, Councilmember, and Council Alternate is enclosed with this letter.

The meeting is scheduled to run from 1:30 to 4:30. However, as the balloting for each position will take place in succession, **YOU MUST ARRIVE ON TIME TO BE ABLE TO VOTE.** Once the voting for any particular position is finished, the polls will close and will not be reopened. Please be sure to arrive on time in order to be certain that you will be able to vote for all positions.

The agenda for the meeting, including the process for voting, appears on the reverse side of this letter.

**In order to be able to vote at the meeting, you must bring:**

- 1. This letter, entitling you to vote**
- 2. Your Snoqualmie Tribal Enrollment Card**

Individuals without their Tribal Enrollment Card will not be able to vote under any circumstances. Individuals who arrive without this letter, but who have their enrollment card, may be able to vote at the discretion of the Election Administrator.
